## PRESIDENT'S MESSAGE /

At the outset I thank you for electing me to lead the association this year. As you are aware, it is going to be a challenging year this time. The staunch unity among the Veterinarians of Kerala helped us to make some crucial strides in our fight for justice. Sustained and united effort is essential to materialise the fruits of our hard work in the past. Issues before us galore day by day. Hurried moves are on to identify and declare the 58 posts of Veterinarians of AH Department which were abolished in paper during the year 2003. This move comes at a time when the Veterinarians of the Department are in a quagmire of confusion over performing the assigned multiple roles-Veterinary service, AHextension, implementation of decentralized plan schemes, and a number of such other responsibilities, many of which are non professional in nature. Our vehement opposition has put an end to the practice of deputing Veterinarians to man meat stalls of Christmas Bazaar. The association calls upon its members to refrain from such non professional activities in future. Our organizational strength should be utilized to change the callous attitude of the departmental authorities towards our demand for reducing the workload of Veterinarians of the department. Veterinary care has been pushed to the backstage; with result the hapless farmers suffer untold miseries. On the face of it the resolution passed in the AGB meeting of KVSSA for the bifurcation of the department into separate wings for Veterinary services and Animal Husbandry Extension assumes greater importance.

Transfer and posting has been a pernicious problem for us in the absence of Transfer norms. Transfer and posting of Veterinarians is done at the whims and fancies of the ruling party, even though the association could effectively intervene and redress many of the grievances of the members in transfer and posting. We are very keen in getting the norms for Transfer and posting promulgated.

Few of our fellow Veterinarians have been crucified for the acceptance of fees in lieu of private practice alleging acceptance of bribe. This is highly objectionable. When it is expressly written in the statute book that the Vets of AHD are free to do private practice outside the office hours, the lack of guidelines for private practice makes us vulnerable to the nefarious designs of few vested interests. Ironically the quack Veterinary practice is on the rise unhindered by the rule of law.

It is imperative that the AH department, all the agencies involved in the sector and the Associations of Veterinarians work hand in hand for the benefit of the farming community and enhance production. At the same time it is equally important to safeguard

the interests of Vets who are the backbone of the AH sector. Many a times the Govt. and the department which wield statutory power forget this. A satisfied cadre can create miracles in the sector.

The association is committed to use all the weapons in its arsenal to accomplish our just demands.

Expecting the unstinting cooperation of everyone of you.

During the first year of commuting, I used to think that a group of chefs are at work at the rear side of the building. During the second year, the cat was out of the bag. ## RKVY Funded SLBP impasse cleared

The Director of AH has denied clearance for the continued implementation of the scheme owing to the reason that the second installment of funds under RKVY has not been received. The association has taken up the matter with the Hon'ble Minister Sri.K P Mohanan and the latter assured not to stop the continuation of feed supply to the 5742 calves enrolled in October 2010.

Sir,

As you are aware, 126 Livestock Inspectors freshly recruited through Kerala Public Service Commission and appointed in various districts in the Department are deputed for training in various LMTCs with effect from 18-01-2012. The absence of these Livestock Inspectors during the fag end of the financial year put the Veterinary Surgeons and Senior Veterinary Surgeons in charge of Veterinary Dispensaries and Hospitals in great hardship in the implementation of decentralized plan schemes and other Departmental schemes to the tune of tens of lakhs. These institutions are already overloaded with work. The situation warrants urgent steps to prevent the Plan funds getting lapsed. Hence I request you to kindly do the needful to immediately entrust the Livestock Inspectors posted at nearby ICDP sub centres with the additional charge of those institutions where the Livestock Inspectors are deputed for training and also where the post of LI remains vacant, for atleast three hours daily.
